Project Name	Southwestern airports, specifically Alfonso Bonilla Aragón Airport, located in Palmira, Valle del Cauca, which serves the city of Cali.			
Project Description	Private initiative project for the adaptation, construction, expansion, operation and economic exploitation of the Alfonso Bonilla Aragón International Airport. It includes interventions on the air and land sides, such as the construction of docks, terminals, boarding bridges, buildings for the Aerocivil and control tower, as well as the expansion of the apron and parking lots, among others. The concession term is 30 years, with 1 year of preconstruction, 6 years of construction and 23 years of operation and maintenance.			
Investment Opportunity	The project includes the creation of a sub-account financed by regulated and non-regulated revenues to enable Aerocivil to carry out modernization works at the Gerardo Tobar Airport in Buenaventura.			
Market Analysis	This project is expected to generate 31,730 direct and indirect jobs per year. Projected passenger traffic at Alfonso Bonilla Aragón Airport (Cali): 16.3 million.			
Financial Projections	The project's revenue projections are being evaluated at the pre-feasibility level.			
Sustainability and ESG considerations	The project entails establishing a dedicated fund for the development of a tourism-focused airport, serving as a catalyst for economic revitalization in remote areas of Colombia.
