Project Name	Pasto - Popayán			
Project Description	High priority project to improve communication in the south of the country (Cauca, Nariño and Putumayo) with Ecuador and the rest of the national territory, guaranteeing long-term operation and maintenance. Includes studies and designs for new dual carriageway variants (Timbío - El Estanquillo and Chachagüí), second carriageway (La Mina - Chachagüí south, Airport - El Estanquillo, Timbío - Popayán, and Popayán western variant), as well as rehabilitation of the existing section (Timbío - El Estanquillo), Daza - La Mina interchange and urban passage through Chachagüí.			
Investment Opportunity	The project is mainly supported by state resources, which minimizes the commercial risk for the private sector. It is considered strategic according to the Intermodal Transportation Master Plan (PMTI), standing out for its resilience and its importance for regional convergence.			
Market Analysis	The project is expected to generate 152,000 direct and indirect jobs.			
Financial Projections	The income projections are TWENTY SEVEN BILLION FIVE HUNDRED FIFTY FIVE THOUSAND SIX HUNDRED THIRTY-NINE MILLION PESOS (\$27,555,639,000. 000 COP) coming from contributions from the Nation in future vigencias, and ONE BILLION THIRTY THIRTY THOUSAND THREE HUNDRED THIRTY ONE MILLION TWO HUNDRED NINETEEN THOUSAND FIVE HUNDRED EIGHT PESOS (\$1,030,331,219,508 COP) from toll revenues, both figures adjusted to December 2022.
